

Patented Non-Butyl Cleaner/Degreaser

DESCRIPTION

The original, patented cleaner/degreaser that contains no butyl or any other solvent, yet cleans better than products that do. It's safer and more environmentally preferred.

BENEFITS

ENVIRONMENTALLY PREFERRED: Patented formulation that removes greasy, oily soil but contains no petroleum distillates.

NO BUTYL: Replaces more personally hazardous cleaner/degreasers containing glycol ethers. NO VOC'S: With no solvents, Activ VIII will not release volatile organic compounds into the air. VERSATILE: Just vary the dilution and it can be used for multiple jobs, from light duty cleaning of files and lockers to heavy duty cleaning of machinery.

NO RINSING: Loosened soil remains suspended in the cleaning solution – and will not re-deposit. Only food contact surfaces need rinsing.

DEODORIZES: Contains a blend of ingredients noted for their ability to deodorize as well as clean.

HOW TO USE

Suggested Dilutions (Ounces per gal. of water) LIGHT SOIL & DAMP MOPPING - 2 oz.; GREASY, HEAVY SOIL - 12 oz.; AIR CONDITIONER COILS - 10 oz.; AIR FILTERS - 8 oz.; EXHAUST FANS - 12 oz.; FOOD PROCESS EQUIPMENT - 8 oz.; LIGHT FIXTURES - 6 oz.; MACHINE TOOLS - 8 oz.; OVENS - Full Strength; PAINTED WALLS & TRIM - 4 oz.; PLASTICS - 4 oz.; SOAP SCUM - 8 oz.; STEEL FILES, LOCKERS - 2 oz.; WASH ROOM FIXTURES - 4 oz.

Use suggested dilutions as a starting point. Adjust downward or upward for your particular cleaning/degreasing job.
Apply liberally with sprayer, automatic scrubber, mop, cloth or sponge. Allow to stand a few minutes.

3. Pick up with a wet vac or wrung out cloth or sponge.

4. Surfaces that food may contact should be rinsed with potable water, otherwise rinsing is not usually required.
